ORDINANCE NO. 2014-05

AN ORDINANCE DECLARING PORTION OF J. CAMPOSANO STREET, LOCATED AT SAN VICENTE NORTE, IRIGA CITY, TEMPORARY CLOSED DUE TO ITS DAMAGED CONDITION WHICH POSES POTENTIAL HAZARD TO THE PUBLIC, PROVIDING PENALTIES THEREFOR AND FOR OTHER PURPOSES.

WHEREAS, the Local Government Units are empowered to exercise powers that are essential to the promotion of the general welfare. They shall ensure the promotion of health and safety and shall preserve the comfort and convenience of their inhabitants;

WHEREAS, the Local Government Units are authorized under Section 21 (a) of the Local Government Code of 1991 pursuant to an Ordinance to "permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction";

WHEREAS, the City Government of Iriga is highly concerned with and committed at protecting the lives of its constituents at all times;

WHEREAS, the portion of J. Camposano Street located at San Vicente Norte, Iriga City, needs to be temporarily closed due to its damaged condition. Heavy rains and Typhoon Glenda aggravated the physical condition of said road which loosens the soil and continually endangers the structure to collapse hence the need for its immediate closure to pave the way for its reconstruction;

WHEREAS, in keeping the mandate of the local code, the Sangguniang Panlungsod of Iriga City, deemed it wise to enact this Ordinance declaring portion of J. Camposano Street, located at San Vicente Norte, Iriga City, temporary closed due its damaged condition which poses potential hazard to the public;

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of Iriga City, that:

Section 1. TEMPORARY CLOSURE. – It is hereby declared that portion of J. Camposano Street located at San Vicente Norte, Iriga City, shall be temporarily closed due to the damaged condition of the road caused by erosion which poses potential hazard to the public.

Said road shall undergo reconstruction that would entail funding requirement of which a resolution requesting the Honorable Congressman of the 5th District of Camarines Sur for fund allocation to answer for the reconstruction shall be immediately passed together with a resolution requesting the DPWH for program of works necessary for the said reconstruction.

Section 2. SUBSTITUTE ROAD. – There shall be an alternate route in lieu of the closed portion of J. Camposano Street which shall be property donated by Mr. Ferrer.

Section 3. PROHIBITIONS. – (a) It shall be prohibited, at any time of the day or night, for all types of vehicles either private or public utility to use or pass through the portion of J. Camposano Street that has been declared temporarily closed by the Sangguniang Panlungsod of Iriga City.

(b) It shall be prohibited for individuals to cross the above mentioned closed road at any time of the day or night.

(c) It shall be prohibited to remove or destroy the barricade at the closed portion of J. Camposano Street.

Section 4. PENALTY CLAUSE. – Any individual found to violate the above said prohibitions of this Ordinance shall, upon conviction of the Court, be subjected to the following penalties:

A) In paragraph (a) and (b) of Section 3 above:

1st Offense – Reprimand

2nd Offense – Fine of P300.00 and 1 Hour Community Service

3rd Offence and succeeding offenses – fine of P1,000.00 and 1 day Community Service

B) In paragraph © of Section 3 above:

Fine of P5,000.00

Section 5. DEPUTATION OF BARANGAY AUTHORITIES – The Barangay Officials and their deputies are hereby authorized to apprehend violators of this Ordinance.

Section 6. REPEALING CLAUSE – Any Ordinance, Order, Memorandum, Rule or Regulation which is inconsistent with the provision of this Ordinance is hereby modified or repealed accordingly.

Section 7. EFFECTIVITY CLAUSE. – This Ordinance shall take effect Fifteen (15) days after its publication in a newspaper of local circulation within the province or its posting in at least Three (3) conspicuous places in the City.
